

System 3 Year Limited Cross Ship Parts Warranty

Hill Country Computer (hereinafter referred to as HCC) warrants to the original purchaser that this computer will be free from defects in materials and workmanship for a period of three years from the date of invoice. This warranty applies to the components comprising the system unit, including: CPU, motherboard, memory, hard drive, floppy drive, video card, cd-rom drive, dvd drive, LS-120 drive, faxmodem, network interface card, keyboard, mouse, case, power supply and other standard components normally carried and offered for sale by HCC.

Monitors, scanners, speaker sets, external drives, tape backup drives, backup media and power protection devices are covered under their respective manufacturer warranty.

All component items not normally carried and offered for sale by HCC or otherwise identified as "special order" are covered under their respective manufacturer warranty.

This warranty is a limited warranty and; as the sole remedy for a breach of this warranty, HCC will at its discretion replace defective components with new or reconditioned components of equivalent or better performance prior to the receipt of failed components returned freight prepaid by the customer. The customer will provide a valid company Purchase Order or Credit Card number as a deposit. HCC will confirm component failures upon receipt at the servicing HCC facility. Component failures that cannot be confirmed, or components that have, in the sole opinion of HCC, failed because of damage caused by accident, misuse, improper handling, misapplication, lack of proper maintenance or act of God, will be returned to the customer freight prepaid and the replacement component will be invoiced. If the defective component is not received at the servicing HCC facility within 10 business days of shipment of the replacement component, the replacement component will be invoiced. Replacement components and repair service are warranted for 30 days or the balance of the original system warranty period.

HCC will make every effort to complete service requests under this warranty in the same business day and ship the replacement component freight prepaid by normal surface transportation routing.

HCC IS NOT LIABLE AND SPECIFICALLY DISCLAIMS ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF A BREACH OF THIS WARRANTY OR FOR ANY SOFTWARE OR DATA THAT MAY BE LOST DUE TO HARDWARE FAILURE.

In order to take advantage of this warranty, the customer must provide a valid proof of warranty purchase.

Hardware additions, software not preinstalled by HCC, upgrades, modifications, or configuration changes done by the customer are not covered by this warranty.

EXCEPT FOR THE WARRANTIES SET FORTH HEREIN, HCC DISCLAIMS ALL OTHER WARRANTIES EXPRESS OR IMPLIED INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. ANY IMPLIED WARRANTIES THAT MAY BE IMPOSED BY APPLICABLE LAW ARE LIMITED TO THE DURATION OF THIS LIMITED WARRANTY.
